Global Share Alliance completes migration of first major cross-border client

Old Mutual plc transitions to new global registry provider; Major migration marks new milestone in global registry services

Sydney, 10 November 2014 – The Global Share Alliance (GSA) today confirmed it has successfully completed the migration of its first major cross-border listed securities client, the FTSE-100 international savings and investment firm, Old Mutual plc.

Under the new arrangement, GSA partners Equiniti and Link Market Services South Africa will provide share registry and investor services to Old Mutual shareholders on the London and Johannesburg stock exchanges.

The Old Mutual registry business represents more than 500,000 records and is one of the largest register in South Africa. The GSA partners tendered for Old Mutual's registry service in both South Africa and the United Kingdom earlier this year.

Established in 2011, The GSA is a worldwide network of registry and financial service providers representing in excess of 40 million shareholder records and 5,000 companies worldwide. The GSA has member partners in the UK (Equiniti), USA (AST and Wells Fargo), Australia (Link Group) and Hong Kong (Tricor).

The successful migration marks a significant milestone for the global registry and transfer agency landscape. A key driver behind GSA's growing market presence is its ability to offer compelling new solutions to listed companies seeking to work with registry market leaders in multiple jurisdictions while maintaining a combined, central point of reporting.

Paul Matthews, Managing Director of Corporate Markets, at Equiniti said: "This is a major achievement for the Global Share Alliance and we are looking forward to delivering high quality services to Old Mutual. The success of the migration will be a springboard to delivering greater choice to global corporations on the delivery of their global registry requirements."
