

## How to complete the Small Estates Declaration & Indemnity form (“Small Estates Package”) – Non-UK Companies

In order for the death of the deceased shareholder to be updated on the Register of Members, in respect of a sole shareholding, it is required that you forward on to us the original Grant of Representation, an official sealed copy by the Probate Office or a scanned image where the holding is less than £30,000.

If you do not intend to apply for a Grant of Representation, you may register the shareholder’s death using our Small Estates Package, provided that the total value of the shares held is not more than £30,000.

If you would like to use our Small Estates Package, please complete the Small Estates Declaration and Indemnity form and return to us completed and signed. You are also required to enclose the following document:

- the death certificate (any photocopies will not be returned)

If you would like to transfer the shares after the death of the shareholder has been registered, please complete a Stock Transfer Form. Our Stock Transfer Form and guidance notes can be found on our website <https://eu.mpms.mufig.com/> and should be completed and returned back to us along with the relevant share certificate(s).

Please be aware that only after the death of the shareholder has been noted on the Register can any documents be amended to note the capacity of the personal representative(s) or the shares be transferred/sold.

Please note that you are under no obligation to use our Small Estates Package and, as an alternative, you can send us a Grant of Representation and we will register the shareholder’s death free of charge.

If you are in possession of the share certificates and wish to have them reissued in a new name, please send these into us with a completed stock transfer form, and we will replace them. Please be aware, however, that any existing share certificates do remain valid.

If you do not have the original share certificate(s) for the total holding and wish to obtain a replacement(s), please send us a signed request for a Letter of Indemnity. Alternatively, please call us on 0800 181 4702 to complete a Letter of Indemnity request over the phone.

Please note that, as Registrars, we are not regulated to provide share valuations.

In the event of legal proceedings against you in connection with any such claim, from time to time upon demand to provide you with any funds you may require to defend such proceedings, and in default of my/our so doing you shall be entitled to admit or settle such proceedings on such terms as you may think fit to recourse to me/us. I/We undertake to obtain and produce a grant of representation of the estate of the deceased in either the Isle of Man, Jersey or Guernsey if the Company needs one in the future.
